**Subject: CONSTITUTION OF COMMITTEE FOR ASSESSMENT OF ENVIRONMENTAL ISSUES RELATED TO SOLID WASTE DISPOSAL ISSUES AND GREENHOUSE GAS EMISSIONS AT MEHMOOD BOOTI, LAHORE**

**WHEREAS**, Environmental Protection Agency (EPA) Punjab is striving hard to provide for the protection, conservation, rehabilitation and improvement of the environment, prevention and control of pollution, promotion of sustainable development.

2. **AND WHEREAS**, the Honorable Lahore High Court, Lahore while hearing the Writ Petition No. 227807/2018 (Haroon Farooq Vs GoP) has taken cognizance of the significant environmental issues arising from greenhouse gas emissions and solid waste management at Mehmood Booti, Lahore;

3. **AND WHEREAS**, it is deemed necessary to conduct a thorough evaluation of the existing situation and formulate effective solutions to mitigate the adverse environmental impacts;

4. **AND WHEREAS**, Section 6(1)(i) of the Punjab Environmental Protection Act 1997 enables to **“establish systems and procedures for surveys, surveillance, monitoring, measurement, examination, investigation, research, inspection and audit to prevent and control pollution...”**

5. **NOW, THEREFORE**, I, Dr. Imran Hamid Sheikh (PAS), in exercise of the powers conferred upon me under Section 6(1)(i) of the Punjab Environmental Protection Act 1997 and in compliance with the directives of the Honorable Lahore High Court, Lahore do hereby constitute a committee comprising of the following experts:

- i. Conduct a comprehensive assessment of the current state of greenhouse gas emissions and solid waste management practices at Mehmood Booti, Lahore.
- ii. Evaluate the existing infrastructure and facilities for solid waste management, including collection, transportation, treatment, and disposal.
- iii. Identify risks and environmental issues associated with this solid waste dumping site.
- iv. Propose immediate and long-term solutions to mitigate greenhouse gas emissions and improve solid waste management practices.
- v. Submit a detailed report, including findings, recommendations, and an action plan till 27th March, 2025 from the date of this notification.
