2. Terms of Reference (TORs)

The committee's terms of reference are as follows:

- Establish a working relationship with PMU, LG&CDD, to thoroughly analyze the PSS and its digital map inventory of land-use plans. This analysis will focus on effective integration of the PSS into EPA's decision-making processes, particularly for Initial Environmental Examination (IEE) and Environmental Impact Assessment (EIA) projects.
- Explore key features of the PSS, such as the "**Automated Zoning Report**" to leverage its potential in informing zoning decisions and preventing violations of approved Land Use Plans.
- Develop a mechanism to modernize the current manual Site Inspection Report (SIR) system to a technology-oriented and less human-intensive reporting system.
- The committee will submit its report by **July 17, 2025**.
