- I. The ASC will conduct aerial surveillance visits to identify pollution hotspots throughout Punjab
  - II. The ASC will gather actionable information for the EPA to enforce environmental regulations and mitigate pollution.
  - III. The Operational Head will be responsible for uploading the detailed surveillance report on Given Google Form, generated and maintained at Strategy and Analysis Wing (SAW) within twenty-four (24) hours of completing each mission.
  - IV. The Incharge SAW shall brief the Director General, EPA Punjab about the said surveillance report and subsequent actions taken in the field, on daily basis.
3. This order shall come into force with effect from **16<sup>th</sup> April, 2025** and shall remain in force until modified or withdrawn.
