Subject: **ORDER UNDER SECTION 6(1)(T) OF THE PUNJAB ENVIRONMENTAL PROTECTION ACT, 1997 REGARDING AUTHORIZATION OF QUALIFIED BODY OR COMPANY FOR HANDLING AND MANAGING RISK WASTE GENERATED BY HOSPITALS**

In continuation of Office Order No. 404/PA/DG/EPA/2025, dated 04.11.2025, it is hereby notified that the last date for public and private hospitals to apply **(only through the online portal at [www.epd.punjab.gov.pk](http://www.epd.punjab.gov.pk))** to the Environmental Protection Agency Punjab for obtaining authorization, in favour of any qualified body, firm, or company, for the handling and management of hazardous healthcare waste of their respective hospitals, is **extended up to 31st January, 2026**.

2. After the expiry of the stipulated time, legal action shall be initiated against the violators under the prevailing environmental laws.
