Subject: DISPOSAL OF SUB-STANDARD FUEL U/S 6(1)(T) OF THE PUNJAB ENVIRONMENTAL PROTECTION ACT 1997

ORDER

WHEREAS, under Rule 3(c), 4(b) and 5(c) of the Punjab Environmental Protection (Smog Prevention and Control) Rules 2023, the use of sub-standard fuel is prohibited.

2. **AND WHEREAS**, Rule 2(1)(n) of ibid Rules defines sub-standard fuel as:

“sub-standard fuel means hard coke, tyres, plastic, rubber, latex, lather, Rexene, tyre-carbon, pyro-oil, rags, plastic waste lumps, hospital waste, hazardous waste or any other such fuels as specified by the Agency”

3. **AND WHEREAS**, it has been reported by field officers of EPA, duly appointed as authorized officers under ibid rule, that some units are involved in consignment, transportation, storage, usage, handling or import of the said fuel. However, no proper mechanism currently exists to dispose it of in an environmentally sound manner.

4. **AND WHEREAS**, it is extremely necessary to remove such sub-standard fuel and discard / dispose it of in an environmentally sound manner to protect environment from its adverse environmental impacts.

5. **AND WHEREAS**, Section 6(1)(t) of the Punjab Environmental Protection Act 1997 empowers the undersigned to ***“take or cause to be taken all necessary measure for the protection, conservation, rehabilitation and improvement of the environment, prevention and control of pollution and promotion of sustainable development”***

6. **NOW, THEREFORE**, I, Dr. Imran Hamid Sheikh (PAS), in exercise of the powers conferred upon me under Section 6(1)(t) of the Punjab Environmental Protection Act 1997 do hereby order that:

- i. *The officers of EPA duly appointed as authorized officers under Punjab Environmental Protection (Smog Prevention and Control) Rules 2023 shall get the sub-standard fuel disposed of through LWMC at the rates duly notified by the said company vide its Ref. No: LWMC/RG-BD/2024-279 dated 12.09.2024.*

- ii. *The said disposal charges, duly calculated by the concerned officer of EPA, shall be paid by the violator, from whose possession such sub-standard fuel has been found, directly in the designated head of account of LWMC as conveyed vide its aforementioned letter:*

- iii. *The violator shall not be allowed to operate till the sub-standard fuel gets completely disposed of by LWMC, after receipt of their charges from the violator.*
- iv. *The disposal charges shall be in addition to the fine imposed under Punjab Environmental Protection (Smog Prevention and Control) Rules 2023 by authorised officers.*

7. This order shall be implemented with immediate effect in the territorial jurisdiction of District Lahore while in other districts *mutatis mutandis*.


