TORs:

- i. The officers will visit the allocated districts / areas for the supervision of performance of District Officers.
- ii. The officers will ensure the following on Main artery and major roads:
 - a. Check any visible smoke from Industrial Units and Brick Kilns.
 - b. Check status of Emission Control Systems (ECS) installed in industrial units.
 - c. Check status of compliance of SOPs by Brick Kilns.
 - d. Check compliance of Plastic Regulations 2023, water conservation orders and SOPs for construction sites.
 - e. At least 20 inspections must be reported by each officer with pictorial evidence using GPS and timestamp Camera.
- iii. The officers may ask the relevant district officers for the provision of Eco-Watch data.
