



EXECUTIVE ORDER

Subject: **MANDATORY INCLUSION OF UNIQUE IDENTIFICATION (ID) NUMBER IN ECO-WATCH APP INSPECTIONS**

WHEREAS, vide this office Executive Order No. 26/PA-DG/EPA/109/2024 dated 29.03.2024, it was made mandatory that all the field inspections shall be recorded on Eco-Watch App to ensure standardized data collection and real-time reporting. Similarly, vide this office letter No.PA/DG/EPA/109/2024/55 dated 20.06.2024 it was made mandatory to allocate Unique ID Numbers to Brick Kilns;

2. **AND WHEREAS**, the comprehensive e-mapping of Industrial Units and Brick Kilns across Punjab has been successfully completed, resulting in the allocation of a Unique Identification (ID) Number to each unit, facilitating precise location and data management;


3. **AND WHEREAS**, the accurate recording of the Unique ID Number alongside the name of the Industry and Brick Kiln during their inspections is crucial for maintaining data integrity and facilitating efficient monitoring and enforcement activities;

4. **NOW, THEREFORE**, I, Imran Hamid Sheikh (PAS), Director General, Environmental Protection Agency, Punjab, do hereby order that all field inspections conducted using the Eco-Watch App shall include the mandatory entry of the Unique Identification (ID) Number of the Industry and Brick Kiln being inspected, in addition to the unit's name. The said Unique ID Number shall be recorded in the field of "Name" in the following manner:

Name of Unit: "Unique ID No. (space) Name of Industry or Brick Kiln (as the case may be)"

5. This order shall come into force w.e.f. **17.03.2025 (Monday)** and shall remain in force until modified / withdrawn.
6. Any contravention of this order by any officer/official of EPA shall attract disciplinary proceeding under PEEDA.
